### Purpose:

The purpose of this report is to provide Council with an update of the current climate action initiatives associated with the Corporate Climate Adaptation Plan (CCAP).

# **Background:**

On July 22, 2019 Council passed a resolution supporting the development of a Corporate Climate Adaptation Plan. The purpose of a Corporate Climate Adaptation Plan is to prepare the Town of Lincoln to adapt to anticipated climatic change and extreme weather, thereby minimizing the severity of the resulting impact.

# Report:

Further to the declaration of a Climate Crisis, adoption of the Corporate Climate Adaptation Plan (CCAP) and extensive efforts that have been ongoing with Council support, staff continue to implement climate action initiatives. Appendix A provides an update on Town of Lincoln Corporate Climate Adaptation Plan Initiatives between Q2 2019 – Q1 2022 including progress and next steps.

Future updates will be on a biannual basis. The next update report will provide an overview of Q2-Q4 2022 and is anticipated to be brought to Council in January 2023.

Planned community engagement and communication will also be facilitated on Speak Up Lincoln.
