#### **Recommendation:**

**Receive and file** Report PW-08-19 for the 2019 Capital Road Resurfacing and Rehabilitation project award;

**Approve** the contract award for the 2019 Asphalt Paving Program tender to Brennan Paving Ltd. for the amount of \$528,884.40 as outlined in the report

**Approve** the contract award for the 2019 Rural Road Rehabilitation Program tender to Norjohn Contracting and Paving Ltd. for the amount of \$854,114.75 as outlined in the report

**Approve** the Mayor and Town Clerk to sign and seal the contract documents on behalf of the municipality.

## Purpose:

To examine the results of the 2019 Asphalt Paving Program tender and the 2019 Rural Road Rehabilitation Program tender and obtain approval to proceed with construction of both phases.

## **Background:**

The Town's annual Road Resurfacing and Rehabilitation Program includes both urban and rural roads with a balanced approach of focusing on both "keeping the good roads good" via resurfacing strategies and also addressing roads in poor condition via rehabilitation work. The road candidates for this years' program were selected and based on the recommendations from the Road Rationalization Review and the Town's Ten (10) Year Capital Plan forecast. Please refer to the location map for the roads included in the approved 2019 Capital Road Resurfacing and Rehabilitation Program.

## **Report:**

The Road Resurfacing and Rehabilitation Program involves two methods of road construction. Urban roads are resurfaced using a hot mix asphalt while the Town's rural roads are rehabilitated with surface treatment. To secure competitive pricing in both areas of construction, staff separated this year's program into two tenders.

Table 1.0 summarizes the approved 2019 Capital Road Resurfacing and Rehabilitation road candidates by construction type.

Tenders for the Road Resurfacing and Rehabilitation Program were issued in February. The 2019 Asphalt Paving Program tender closed on February 21, 2019 and the 2019 Rural Road Rehabilitation Program tender closed on March 12, 2019.

The bid results for the 2019 Asphalt Paving Program are summarized in Table 2.0:

The low bidder, Brennan Paving Ltd. has worked for the Town of Lincoln in the past and has completed similar road resurfacing and rehabilitation projects satisfactorily. As such, staff recommends that the award of the subject tender be awarded to Brennan Paving Ltd.

The bid results for the **2019 Rural Road Rehabilitation Program** are summarized in Table 3.0:

The low bidder, Norjohn Contracting and Paving Ltd. has worked for the Town of Lincoln in the past and has completed similar road resurfacing and rehabilitation projects satisfactorily. As such, staff recommends that the award of the subject tender be awarded to Norjohn Contracting and Paving Ltd.

#### **Provisional Roads (optional)**

In keeping with Council's mandate to optimize the annual Road Resurfacing and Rehabilitation Program capital budget allocation, council approved a list of provisional (optional) roads in the 2019 program scope that were included with the tender. Since the tender results were favourable, a provisional road has been included in the tender award recommendation.

Table 4.0 summarizes the recommended provisional roads included in the contract and provides the tendered budget allocation for each road as well.

Based on the above, the total estimated project costs can be accommodated by the funds allocated with the approved budget. Further, staff recommends that the estimated budget surplus of \$96,885.85 be used for the rehabilitation of provisional roads listed in Table 4.0

## **Conclusion:**

Public Works staff have reviewed each project tender and have worked with both low bidding contractors previously with satisfactory results. In addition, both tenders were received within budget. As such, staff recommend that Council award the 2019 Asphalt Paving Program contract to Brennan Paving Limited and the 2019 Rural Road Rehabilitation contract to Norjohn Contracting and Paving Ltd. as outlined in this report.
