## BY-LAW NO. 2019-81

#### A BY-LAW TO AMEND BY-LAW NO. 89-2000 (89-28), BEING A BY-LAW REGULATING TRAFFIC AND PARKING ON LOCAL MUNICIPAL ROADS

WHEREAS the Council of the Corporation of the Town of Lincoln enacted By-law No. 89-2000 (89-28) on April 3rd, 1989, to regulate traffic and parking on local municipal roads;

AND WHEREAS under the provisions of Section 170 of the Highway Traffic Act, a Municipal Corporation may by By-law prohibit or regulate parking, standing and stopping on a roadway in accordance with the regulations set out in the Act;

AND WHEREAS after considering Report PW-17-19, the Council of the Corporation of the Town of Lincoln deems it necessary and expedient to implement on-street parking restrictions in the Cherry Heights Subdivision by amending Schedule "C" of By-law No. 89-2000 (89-28), as amended;

NOW THEREFORE, THE COUNCIL OF THE CORPORATION OF THE TOWN OF LINCOLN ENACTS AS FOLLOWS:

1. That Schedule "C" of By-law No. 89-2000 (89-28), as amended, is hereby further amended by deleting the following from the respective columns in the said schedule:
