RECOMMENDATION:

1. That report AD 17-05 regarding the Town of Lincoln Transit Pilot Project be received for information.

EXECUTIVE SUMMARY:

The purpose of this report is to provide Council with an update on the planning of the transit pilot in Lincoln.

HISTORICAL BACKGROUND:

Currently, the Town of Lincoln does not have a municipal transit service. The only transportation services offered in the community is through taxi services from other municipalities which is quite costly, Niagara Specialized Transit for individuals meeting specific criteria, or private livery service.

The Town of Lincoln has several senior homes, retirement communities, homes for individuals with physical and cognitive disabilities, and a youth population that require a growing need for transportation.

As such, The Town of Lincoln identified developing a transit pilot.

FINANCIAL - STAFFING - LEGAL CONSIDERATIONS:

Financial: The transit pilot has been included in the 2017 approved operating budget for \$50,000. Staff will be including \$100,000 for the 2018 budget to sustain pilot through 2018.

Staffing: Staff will project manage this pilot as outlined in the staff comments below. Public Works is the lead department with support from Planning and CAO's office

(Economic Development Officer and Senior Communications Advisor). An RFP will be issued to seek a service provider to operationalize and provide service throughout the pilot.

Legal: Legal opinion will be secured through the development of the RFP to ensure all risk and liability considerations are examined for the Town.

RELEVANT CONSULTATION:

As per the pilot scope below, staff will be consulting with several stakeholder groups to ensure that the route planning and fees are optimized for riders. Additionally, staff have been corresponding with other municipalities with comparable service to seek lessons learned and considerations.

STAFF COMMENTS:

Complete communities are an integrated approach to transportation planning, land use planning, and community design to provide a good quality of life and meet the needs of people of all ages, abilities, ethnicities, and income levels. Public transit is key to community livability and sustainability. The Town of Lincoln's Official Plan outlines that a sustainable community is achieved by:

- Providing choices and opportunities for housing, employment, transportation, social, recreational and cultural amenities
- Making efficient use of its infrastructure by focusing on a compact, mixed-use, walkable, bikeable and connected community

As such, public transit:

- 1. Provides mobility to members of the community
- 2. Supports the introduction of the future GO train service in Lincoln
- 3. Facilitates economic development and support labour workforce development/accessibility
- 4. Supports future plans for sustainable development and intensification, as outlined in the Town's Official Plan
- 5. Contributes to a higher quality of life, including improved health and community participation rates

Staff have developed an outline of the scope of the pilot, along with corresponding timelines as follows in Table 1.

COMMUNICATION/ENGAGEMENT OVERVIEW:

As part of the pilot scope, a public engagement process will occur to validate the proposed route and fees. Additionally, a comprehensive communications strategy will be developed to promote the pilot, share benefits of using public transit, encourage ongoing ridership, and ensure riders understand schedule. Throughout the pilot, ridership will be monitored closely and project lead will work closely with Senior Communications Advisor to implement further communications strategies to encourage ridership or clarify route and/or schedule.

ALIGNMENT TO CORPORATE PLAN:

Economic development is a priority area for this term of Council, specifically, "Build our economic capability by creating an investment-friendly environment, securing our economic future and improving the quality of life for our residents". Public transit increases traffic to downtown cores, increases access to shopping districts, provides an affordable option to move people and goods across the municipality, increases access to health care and other essential services, and connects residents and visitors to the Town's recreational, cultural, heritage, and tourism.
